

***CONDITIONS OF PURCHASE AND USE OF VIP PASS:**

1. The \$69.99 QLD VIP Pass Offer is available on www.myfun.com.au and via 133 FUN only and is not available at Warner Bros. Movie World, Sea World, Wet'n'Wild Water World front gates or any other third party resellers.
2. The \$69.99 QLD VIP Pass Offer is restricted to Queensland residents and residents of Northern New South Wales postcodes 2450 – 2490 only. Proof of residency must be shown on first entry.
3. The \$99.99 National VIP Pass Offer is available on www.myfun.com.au, via 133 FUN, the Warner Bros. Movie World, Sea World, Wet'n'Wild Water World front gates and selected third party resellers.
4. A \$4.95 booking fee applies per transaction on all purchases through myfun.com.au. A \$5.95 booking fee applies per transaction on all purchases through 133 FUN. A 1.5% surcharge applies to all American Express and Diners Card transaction through myfun.com.au. A \$5.95 surcharge applies to all American Express and Diners Card transactions through 133 FUN. A \$3.50 surcharge applies to all Mastercard and Visa transactions through 133 FUN.
5. At time of purchase, personal data for each Pass holder must be completed.
6. VIP Pass entitles holder to entry to Warner Bros. Movie World, Sea World and Wet'n'Wild Water World from date of purchase until 30 June 2011 inclusive BUT NOT:-
 - to special events conducted outside advertised park trading hours; nor
 - on Christmas Day.
7. On any valid day entry is permitted ONCE to each selected park. Any extensions or refunds as a result of limited visitation or suspension are not allowed.
8. VIP Pass does not entitle the holder to:-
 - entry to the Sea World Resort Water Park, Sea World Helicopters or Sea World Animal Adventures; nor

10. VRTP may cancel or suspend the VIP Pass and/or remove the holder from a park if they breach ANY park rules which are set out at the front gate of each park. VRTP reserves the right to close rides and/or attractions on a permanent or temporary basis during the life of the VIP Pass.
11. The original VIP Pass must be presented to be allowed entry to a park. NO PASS - NO ENTRY
12. If the VIP Pass is lost, stolen or damaged \$20.00 is payable to obtain a replacement pass. If the VIP Pass is stolen the replacement fee may be waived if a documented police report is provided.
