This document contains the terms and conditions governing the use of our gift card (“the Card”). The person in possession of the Card (“you”) agrees to be bound by these terms and conditions of use. The terms and conditions shown on this web site may change from time to time without prior notice to you but we will use reasonable endeavours to ensure any change made is not to your detriment.

1. If the Card is defaced, mutilated, altered, lost or stolen the Card will not be replaced, refunded or redeemed.
2. The Card can be used for the purchase of merchandise or services (exceptions apply) at selected outlets in-park, front gate and the contact centre but are not redeemable for cash nor can you obtain any cash advance using the Card.
3. The Card may be used on more than one occasion.
4. The Card must be used within 12 months from the issue date shown of the back of the Card. Any unused balance upon expiry of the Card cannot be refunded or credited.
5. The Card cannot be reloaded [i.e. value cannot be added to it].
6. The minimum value of any purchase that can be made using the Card is \$5.
7. Any purchase that you wish to make that exceeds the available balance of the Card shall require you to pay the difference by another payment method eg. cash or credit.
8. You are liable for all transactions on the Card except to the extent to which there has been fraud or negligence by us or any of our employees.
9. The Card may not be resold nor is it refundable unless required by law.
10. We reserve the right to limit the number of the Cards purchased by any person or entity.
11. We reserve the right to refuse any request for redemption of the Card.
